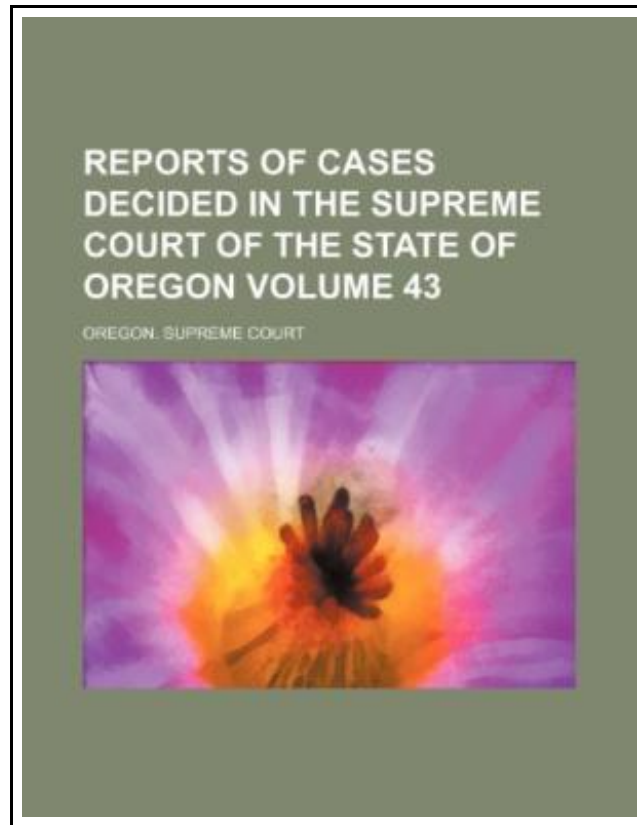

The reason for the rule is that the sheriff could not be made liable in an action by the plaintiff in the writ for not levying upon property not that of the judgment debtor, and the person having the paramount title may take it from him as well as from the receptor, which would be the end of the controversy so far as the property is concerned: *Learned v. Bryant*, 13 Mass. 224; *Fisher v. Bartlett*, 8 Me. 122. Nor will he be permitted to show that the property was not at the time of the attempted levy and delivery of the receipt, or never had been, in the possession of the defendants in the writ; and upon the same principle he will not be permitted to show that the Property was not in his possession, or that no sufficient levy of the writ had been made by the officer having it in charge for execution: *Bangs v. Beacham*, 68 Me. 425; *Spencer v. Williams*, 2 Vt. 209 (19 Am. Dec. 711); *West v. Thompson*, 27 Vt. 613; *Jewett v. Torrey*, 11 Mass. 219; *Lyman v. Lyman*, 11 Mass. 317; *Hunter v. Peaks*, 74 Me. 363. With these observations, we will recur to the questions...
